8. Nationality/Citizenship:

A candidate must be either (i) a citizen of India or (ii) a subject of Nepal or (iii) a subject of Bhutan or (iv) a Tibetan refugee who came over to India before 01.01.1962, with the intention of permanently settling in India or (v) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, east African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaha, Ethiopia and Vietnam, with the intention of permanently settling in India, provided that the candidates belonging to categories (ii), (iii), (iv) and (v) above, should be a person in whose favor a certificate of eligibility has been issued by Government of India. A candidate in whose case a notification of eligibility is necessary may be admitted to the interview conducted by the Bank but on final selection, the offer of appointment may be given, only after the necessary eligibility certificate has been issued to him by the Government of India.

9. Educational Qualification:

Pass in XII Standard examination or equivalent from a recognized University/ Board/Central/State/UT administration. Applicants should attach attested certificates / marks cards evidencing their educational qualification.

10. Sports Qualification:

Should have represented the State in National event, or the District in State Level event with distinction, or the university in an Inter-university event with Distinction or a member of the Combined universities Team. (Preference will be given to current State players).
